For speedy redress of all grievances, the **Grievance Redressal Committee** [GRC] of GIET shall take a decision within 15days of receipt of grievance and the decision shall be informed to the concerned complaint. In case any appeals complaint not satisfied with the decision of the grievance Redressal committee of GIET, may send their appeal to OMBUDSMAN of affiliating university i.e. BPUT directly to get justice.
